**FANTASY FOOTBALL COMPETITION (the “Competition”)**

**Section 1: Eligibility and How to Enter the Competition**

1. This Competition is run by Starling Bank Limited, company number 09092149 registered at 2 Finsbury Avenue, London EC2M 2PP, England (“Starling”, “we”, “us”, “our”). Starling is the promoter of this Competition.
2. These Terms and Conditions include the General Competition Terms and Conditions located on Starling’s website [here](#). If the General Competition Terms and Conditions (or any other communications, including advertising or promotional materials) and these terms and conditions for the Competition don’t match up, these Terms and Conditions will apply over the other terms.
3. This Competition is open to:
  - 3.1. Residents of the United Kingdom;
  - 3.2. aged 14 and older.
4. This Competition is free to enter and no purchase is needed. However, to successfully enter this Competition, participants must by the closing date of the Competition:
  - 4.1. create a player account and submit a team on Starling Bank’s Women’s EURO Fantasy Football as described in more detail on <https://womenseurofantasyfootball.starlingbank.com>;
  - 4.2. provide an email address with which they can be verified and contacted by Starling (“Contact Details”);
  - 4.3. ensure that their player account is not deleted until 14th August 2022.
5. The Competition will run from 08:00 BST on 28/06/2022 to 16.59 BST on 31/07/2022
6. This Competition will be for one box package for eight people including:
  - 6.1. access to a box at London Wembley Stadium with a complimentary bar and meal provided by a private chef and host;
  - 6.2. eight tickets to the Women’s FA Cup Final 2023 at London Wembley Stadium on 14th May 2023 hosted in a box (“Giveaway”).
7. Participants may earn one entry into the Competition for every account they create and team they submit.

**Section 2: The Process**

1. The Competition run time set out in clause 5 of Section 1 relates to the period in which competition entries can be submitted and not the times and dates in which the Women’s FA Cup Final 2023 will take place.
2. Any entries received outside of the relevant Competition period will not be accepted.
3. Entries must be submitted via the Starling’s UEFA Women’s Euro Fantasy Football 2022 webpage available [here](#). Entries submitted via any other means will not be accepted.
4. The Giveaway winner will be contacted by Starling via email within 14 working days following the Competition closing date. Starling will make reasonable attempts to contact the winner on the Contact Details provided to administer the Giveaway.
5. In situations where: (i) the winner does not provide all required information to Starling as set out in these terms and conditions within a reasonable timeframe; or (ii) the winner cannot be contacted or is not available,

this will result in the winner forfeiting their Giveaway and in such situations, Starling will be entitled to select at random another winner.

6. The Giveaway is not negotiable or transferable and there is no cash alternative for tickets which are unused for any reason (including but not limited to in the event of cancellation, abandonment, postponement or replaying of a match outside of Starling's control).
7. Winners will not be able to select specific seats at the matches as these will be allocated by the FA.
8. Tickets can be used by anyone aged two and over, but at least one adult over the age of 18 must be in attendance in the box and at the match which the winner has won tickets for, and all attendees under the age of 18 must obtain permission from a parent or guardian.
9. Each winner and (if applicable) any of their guests are responsible for their own costs and expenses incurred in relation to the Giveaway.
10. The Giveaway is run by Starling and is not in any way administered by UEFA or the FA. By entering you acknowledge that UEFA, shall not have any liability to you in connection with the Competition, and except as otherwise set out in the Ticket Terms in Section 3 - clause 2 below, the FA shall not have any liability to you in connection with the Competition.

### **Section 3: General Information**

1. Participants are deemed to have accepted and agreed to be bound by these terms and conditions and the General Competition Terms and Conditions upon submitting an entry to the Competition. We reserve the right to refuse competition entries or refuse to award the Giveaway to anyone in breach of these terms and conditions, the General Competition Terms and Conditions or any applicable law or regulation.
2. Participants must make sure that they and their guests (where applicable) comply with the FA's ticketing terms which will be made available during the tournament period ("Ticket Terms").
3. We reserve all rights to disqualify you if you do not agree with the Ticket Terms or your conduct is contrary to the spirit or intention of the Competition. In such circumstances, Starling will be entitled to select at random another winner.
4. We will process your (and, where applicable, any of your guests) personal data in line with Starling Bank's Privacy Notice, available here <https://www.starlingbank.com/legal/privacy-notice/> and all applicable data protection and privacy legislation in force from time to time in the UK. Personal data supplied during the course of a Competition may be passed on to certain third party companies (such as the FA) only insofar as required for the fulfilment, delivery and/or arrangement of the Giveaway.
